OFFICIAL ACTS

ACT I, enacted on March 23, 2015 RECOGNITION OF NEW STUDENT ORGANIZATIONS

- **Section 1.** Supplemental to existing policies established by the Boston University Student Activities Office regarding the formation of new student activities, an organization seeking to operate within the general scope of the Boston University School of Hospitality Administration and receive financial appropriations from that school must first be authorized with approval from at least two-thirds of the voting Members of this Council.
- **Section 2.** Recognition of a student organization by this Council does not guarantee the recognition of that group by the Boston University Student Activities Office.
- **Section 3.** Recognition of a student organization by this Council does not guarantee the appropriation of funding to that organization by the Boston University School of Hospitality Administration. The administrators of the school reserve the right to determine such an appropriation, and its value.
- **Section 4.** This act shall be effective immediately after passage. The Boston University School of Hospitality Administration Presidents Council, in accordance with its laws, shall enforce this act. All acts of the Boston University School of Hospitality Administration Presidents Council in conflict with this legislation are hereby declared null and void.

ACT II, enacted on March 23, 2015 COORDINATION OF PROGRAM SCHEDULING

- **Section 1.** No recognized student organization within the Boston University School of Hospitality Administration may host an event open to its general membership or a broader population at a time in which another organization has already scheduled another event similarly open to its general membership or a broader population.
 - **A.** An "event" is a defined as a scheduled activity hosted by a student organization. To "host" an event means to be its sponsor and/or organizer. All events and hosts shall be recognized by the Boston University School of Hospitality Administration Student Government, who shall also note the date and time of the request.
 - **B.** If a dispute arises over which event is considered primary and secondary, the Council Chair and President of the Boston University School of Hospitality Administration Student Government shall review the event planning records of that government and shall name the primary event as that which was earliest brought to the attention of the government with a definite date and time for the event.
- **Section 2.** This policy may be voided if the host of the originally scheduled event provides written approval to the second organization seeking to host an event at the same time that that second event may be hosted as desired or under certain conditions, pending mutual agreement.
 - **A.** Any form of consent or mutual agreement to host simultaneous events must be communicated to the Boston University School of Hospitality Administration Student Government.
 - **B.** In the event approval is not granted by the host of the primary event, or should mutual agreement not be reached on the conditions with which the second event is requested to be hosted, the organization seeking to host the secondary event may appeal the request to the Council Chair and President of the Boston University School of Hospitality Administration Student Government who shall have a right to final authorization.

Section 3. This act shall be effective immediately after passage. The Boston University School of Hospitality Administration Presidents Council, in accordance with its laws, shall enforce this act. All acts of the Boston University School of Hospitality Administration Presidents Council in conflict with this legislation are hereby declared null and void.

ACT III, enacted on March 23, 2015 LIMITING THE OFFICERSHIPS OF INDIVIDUAL STUDENTS

Section 1. No individual shall concurrently and simultaneously hold more than two (2) officerships across the recognized student activities of the Boston University School of Hospitality Administration. No president of a student activity recognized by the School shall concurrently and simultaneously hold another officership of any form across the other student activities recognized by the School. An individual may run for multiple officerships for each and across all student activities and they may be duly elected to each and any role, but they may not accept more than two (2) non-presidential positions of responsibility or one (1) presidency.

Section 2. This act shall be effective during the Spring 2015 electoral cycle. The Boston University School of Hospitality Administration Presidents Council, in accordance with its laws, shall enforce this act. All acts of the Boston University School of Hospitality Administration Presidents Council in conflict with this legislation are hereby declared null and void.
